**Cancellation policy:** Refunds available 14 days in advance. Cancellations within 13 days from reservation will be charged a \$10 service fee and forfeit the first night's use fee. For a single night's reservation, you will forfeit the site fee, but no cancellation fee will apply.

**No show policy:** A no-show is one who does not arrive at a campground or cancel the reservation. Reserved campsites will be held until check-out time on the day following your scheduled arrival and forfeited afterwards.

**Directions from Hwy 20:** Take Foley Drive towards Burns Paiute Reservation, turn right onto Paiute Street, and turn right into the gravel driveway.

## Campground Rules

**Burns Paiute Reservation is smoke-free and alcohol-free.** We ask you please observe and respect these rules while camping with us.

**Leave no trace.** We will have limited trash bins and encourage you to be good stewards of the land.

**Check in:** 10:00 AM - 4:00 PM | **Check out:** Before 4:00 PM  
When you arrive, please check in with the Camp Manager.

**Quiet hours are 10 PM – 6 AM.**

**Be fire safe.** Please practice fire safety and observe any burn bans that may be in place.

### Pet Policy & Safety Guidelines

All pets must be registered on the reservation form. Max 2 pets per site. Please be sure to control your dog at all times and clean up after them, immediately. Do not allow dogs to interfere with, threaten, or attack people, animals, or wildlife.

### Liability Waiver and General Release

A representative of each group using the Campground shall sign the Liability Waiver and General Release form as a condition to their use of the Campground. Failure to sign the Liability Waiver and General Release shall result in that group being refused the right to use, and to be removed from, the Campground.

## **BURNS PAIUTE TRIBE**

### **LIABILITY WAIVER AND GENERAL RELEASE FOR BURNS PAIUTE TRIBE CAMPGROUND AND POWWOW**

The Burns Paiute Tribe (Tribe), which hosts the Burns Paiute Tribe's 2025 Powwow, is providing campground facilities for Powwow attendees (the "Campground"). The Tribe cannot, and does not, prevent you and those in your group from personal injury or property damage while at the Campground or the Powwow. As a condition to your stay at the Campground, and/or attendance at the Powwow, you hereby waive any claim you may have against the Burns Paiute Tribe, its officers, employees and agents (the "Released Parties"), for personal injury or property damage and hereby release the Released Parties for the same.

**ASSUMPTION OF RISK:** I have read and understand the above waiver and release concerning my stay at the Campground and attendance at the Powwow. I hereby choose to accept the risk for me and for my family members or others in our group in order to stay at the Campground or attend the Powwow.

**WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive my right to bring suit against the Released Parties in connection with my stay at the Campground and/or attendance at the Powwow. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims if negligence, and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

**OTHER TERMS:** I fully understand and agree that (a) this Release is intended to be as broad and inclusive as permitted by the laws of the Burns Paiute Tribe; (b) if any portion of this Agreement is for any reason held invalid or legally unenforceable, then the balance shall, notwithstanding, continue in full force and legal effect; and (c) I have had the opportunity to ask questions about this Agreement and I fully understand its terms and meaning.

**I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS WAIVER AND GENERAL RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE:**
